Child support <b>received</b> for the children in your household. Do not include foster care or adoption payments.

Money received, or paid on your behalf (e.g., payment of your bills) by someone other than you and your spouse (e.g., parents, grandparents, aunts, uncles, friends), not reported elsewhere on this form for housing, food, utilities, transportation (e.g., car payments, insurance, etc.), and personal expenses. Include distributions from a 529 plan owned by someone other than you.
