

## January 2015

### January 26, 2015 | 9:30 a.m.

At 9:30a.m. an officer responded to a call from a faculty member reporting that a student was feeling faint in classroom S103. The student advised the officer that she was well enough to drive to her parent's office which was in the area. Copy of report to the Associate Dean of Student Affairs.

## February 2015

### February 2, 2015 | 7:30 a.m.
