Job Title: Reference and Instruction Librarian

#### **SUMMARY**

This position is responsible for course-related and course-integrated library instruction, in-person, phone, email and virtual reference service platform; development of print and web-based research and instructional materials; consultation with faculty to support course development and assignments; and participation in collection development with responsibility for building and maintaining collections across the curriculum. Some evening and weekend work required.

#### **ESSENTIAL DUTIES AND RESPONSIBILITIES**

- 1. Plan, deliver and evaluate library instruction and reference services for students, faculty, groups, classes and individuals through various formats on Library resources.
- 2. Assist in the development of the students' critical thinking and information and data literacy skills.
- 3. Conduct ongoing assessments of student learning and contribute to departmental assessment projects.
- 4. Assist Library staff by working with vendors and the Madonna University Information Technology department to ensure electronic resources remain accessible and current. Assist in maintaining the Library's webpage and associated functions.
- 5. Serves as liaison to a designated academic unit(s) by attending unit meetings and serving as a communication point of contact
- 6. Maintain the University Library archival and records content within professional, university, and Felician guidelines.
- 7. Manages the Library's collection and catalog ensuring listings are current, align with Library of Congress standards and meet the needs of Madonna's academic community for instruction and accreditation purposes.
- 8. Stay current and, as time allows, contribute to professional literature, professional organizations, and scholarly developments in the areas of reference, library instruction, and instructional technology.
- 9. Provide support for Inter-Library Loan and Periodicals as needed.
- 10. Demonstrate a strong understanding of diversity, equity, inclusion, accessibility and justice initiatives for academic libraries.
- 11. Other duties as assigned.
